BUMA Secures IDR 107.8 Trillion Contract Extension from Bayan Group Subsidiary

- *PT Bukit Makmur Mandiri Utama (BUMA), the principal subsidiary of PT Delta Dunia Makmur Tbk (Delta Dunia Group), has successfully extended a coal mining contractor contract with PT Indonesia Pratama (IPR), a subsidiary of PT Bayan Resources Tbk (Bayan Group), on October 23, 2024.*
- *The contract extension spans eleven years, starting in 2024, and will significantly increase total overburden removal to approximately 1.827 billion bcm and coal production to 465 million tons over the contract period.*
- *The value of the contract has significantly increased to approximately IDR 107.8 trillion or equivalent to USD 7.8 billion.*
- *This contract extension signals BUMA's success in growing its core Indonesian business.*

Jakarta, October 28, 2024 – PT Bukit Makmur Mandiri Utama (BUMA), the principal subsidiary of **PT Delta Dunia Makmur Tbk (Delta Dunia Group, IDX: DOID)**, announces its success in securing a long-term contract extension with **PT Indonesia Pratama (IPR)**, a subsidiary of **PT Bayan Resources Tbk (Bayan Group)**. The signing of this amended agreement occurred on October 23, 2024.

The contract extension period spans 11 years, from 2024 to 2035, and will significantly contribute to BUMA's revenue, amounting to approximately IDR 107.8 trillion or equivalent to USD 7.8 billion. The agreement includes a substantial increase in overburden removal, reaching 1.827 billion bcm, and an increase in coal production to 465 million tons over the contract period.
